I'm writing this letter to explain what had happened and why this Uniform Business Report was not done. My partner Dave Fontaine thought I had taken care of it so he never mentioned it until now.

This past year I was very sick again. Three years ago I had triple by-pass surgery. Since then I never felt right. I finally convinced my doctor that something was wrong my chest still had discomfort all day. Being diabetic that didn't help. Well they found 3 arteries blocked, they put angioplastic balloons in and that took over 3 weeks to do because I was allergic to the dye they used during each procedure. Going in and out of the hospital and being under observation before and after it took a long time. The only thing that I could think of, is if I'm going to live another day and that was very scary for me. This process took from April to November and even though it's over I still have a fourth artery that only functions at 10% and the discomfort is still there. I have to have open heart surgery sometime in the future, so I live every day hurting (over)
