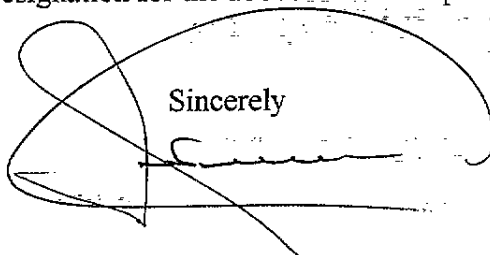

ARTICLES OF INCORPORATION

PANAMERICANIST MOVEMENT FOUNDATION, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the corporation is **PANAMERICANIST MOVEMENT FOUNDATION, INC.**

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of striving for the Continental Integration of the Americas; to fight poverty, to seek relief for the victims of narcoterrorism, through humanitarian programs and donations, and to support nations and politicians engaged in these endeavors, and to that effect, engaging in any activity(ies) permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue Five hundred shares (500) of One Dollar(s) (\$1.00) par value Common Stock, which shall be designated "Common Shares".

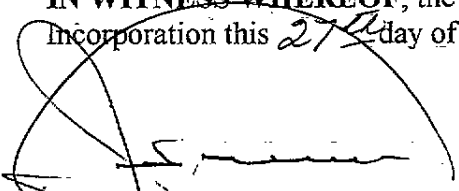

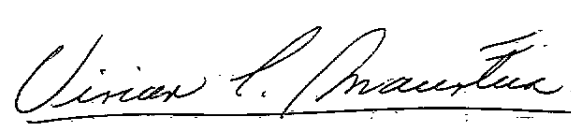

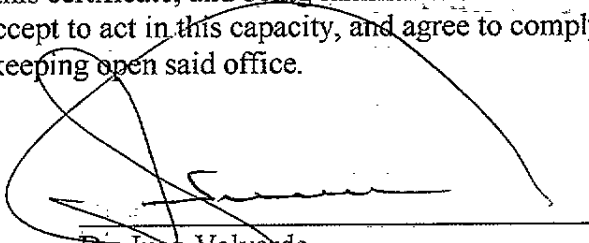
