ARTICLES OF INCORPORATION

GALAXY JEWELERS, INC.

ARTICLE I - NAME

The name of the corporation is GALAXY JEWELERS, INC. with a mailing address of 1700 W. New Haven Ave., #K991, Melbourne, FL 32904 and telephone number of 407/726-0005.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
