CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF ACCESS CONTROLS, INC.



ACCESS CONTROLS, INC., a Florida corporation, under its corporate seal and the hand of its President, JAMES W. GORDON, hereby certifies the following:

The Board of Directors and all Stockholders of said corporation at a joint meeting called and held on October 5, 1999 at 2:00 o'clock P.M., adopted the following resolutions:

Be it resolved by the Board of Directors and all Stockholders of ACCESS CONTROLS, INC., a Florida Corporation, that said Board of Directors and all Stockholders deem it advisable and hereby declare it to be advisable that ARTICLE IV — CAPITAL STOCK of the Articles of Incorporation be deleted and the following is hereby substituted in its place:

"The Corporation is authorized to issue twenty million (20,000,000) shares of One Cent (\$0.01) per share par value capital stock. Unless otherwise established by the Board of Directors, all shares of the Corporation are common shares entitled to vote and shall be of one class and one series having equal rights and preferences in all matters. The Board of Directors, by vote of not less than seventy-five percent (75%) of all of the Directors, shall have the power to establish more than one class or series of shares and to fix the relative rights and preferences of any such different classes or series."

Be it resolved by the Board of Directors and all Stockholders of ACCESS CONTROLS, INC., a Florida Corporation, that said Board of Directors and all Stockholders deem it advisable and hereby declare it to be advisable that ARTICLE V—PRE-EMPTIVE RIGHTS of the Articles of Incorporation be deleted
