The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.



The power to adopt, alter, amend or repeal these Articles of Incorporation of the Corporation shall be vested in the Board of Directors by a majority vote.




