IN WITNESS WHEREOF, the undersigned, as President and Secretary of the Corporation, has executed these Articles of Amendment this 29 day of November, 1999.



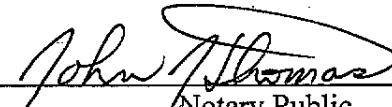
