**ARTICLES OF INCORPORATION
OF
G.R.S. DRYWALL CONTRACTORS, INC.**

THE UNDERSIGNED, acting as sole incorporator of **G.R.S. DRYWALL CONTRACTORS, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

Initial Board of Directors


