These Articles of Incorporation are executed to establish a Corporation under the laws of Florida.
ARTICLE 1 - CORPORATE NAME AND ADDRESS: The Name and Address of this Corporation:

ARTICLE 2 - INCORPORATOR/INITIAL DIRECTOR/REGISTERED AGENT and REGISTERED ADDRESS:

ARTICLE 3 - AUTHORIZED SHARES (Maximum Number and Par Value Per Share):
One Thousand (1000) Shares at One Dollar (\$1.00) per share
ARTICLE 4 - AUTHORIZED SHARES OF STOCK: Any portion of the shares of stock of this corporation may be issued for cash, property, services actually performed or any right or thing having a value at least equal to the full value of the stock to be so issued. Neither promissory notes nor future services shall constitute part or full payment for the issuance of such shares. All issued shares shall be fully paid and non-assessble as though paid for in cash. The stockholders shall be the sole judges of the value of the property, right or thing exchanged for such shares and their judgment of such value shall be conclusive.
