

ARTICLES OF INCORPORATION  
OF  
ALL BREVARD MOVING SERVICE INC.

ARTICLE I. NAME

The name of this corporation is ALL BREVARD MOVING SERVICE INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated "common shares".


