#### ARTICLES OF INCORPORATION

I, the undersigned, of legal age, do cause a corporation under the laws of the State of Florida authorizing the formation of corporations, to be formed as follows:

ARTICLE I

NAME

The name of the corporation shall be:

ARTICLE II

# GENERAL NATURE OF BUSINESS

- f) In any manner to acquire, enjoy, utilize and dispose of patents, copyrights and trademarks, and any license or other rights or interest therein and thereunder.

The amount of capital with which this corporation shall commence business shall be not less than five hundred dollars (\$500.00).
