The undersigned, for the purpose of forming a Professional Association pursuant to the Professional Service Corporation Act hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME:** The name of this corporation shall be HELLER & FRIEDMAN, P.A.

**DURATION:** The term of existence of the corporation is perpetual.

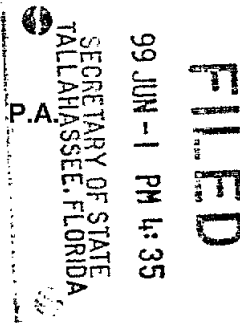

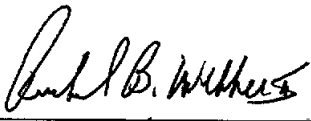

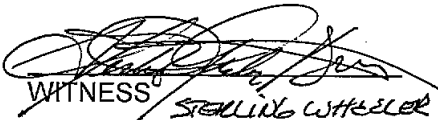
**ARTICLE X**

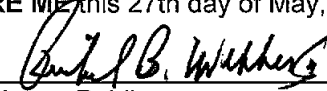
