

ARTICLE I. NAME

The name of the Corporation is **LOVIK, INC.**. The principal place of business of this Corporation shall be **1055 Carter Road, DeLand, Florida 32724**.

ARTICLE II. PURPOSE

This Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

This Corporation is authorized to issue **one hundred (100)** shares of common stock having no par value, which shall be designated "common shares".

The stock of this Corporation is intended to qualify under the requirements of Section 1244. Such actions as are necessary will be taken by the appropriate officers to accomplish this compliance.



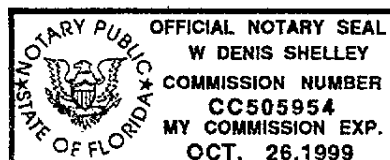
