ARTICLES OF INCORPORATION OF STRATEGIC DEVELOPMENT CONSULTANTS, INC.

ARTICLE I - NAME

The name of the corporation is STRATEGIC DEVELOPMENT CONSULTANTS, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these Articles of Incorporation with the Secretary of State of the State of Florida.
