**ARTICLES OF INCORPORATION**  
of  
**TERRY L. DAVIS, P.A.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby sets forth his intention to form a Professional Service Corporation (hereinafter "corporation") under laws of the State of Florida.

Article 1. Name.

The name of the corporation is TERRY L. DAVIS, P.A.

Article 2. Principal Office.

The principal place of business and mailing address of this corporation shall be 1904 West Main Street, Inverness, Florida 34452.

Article 3. Specific Purpose.

This corporation is organized for the specific purpose of providing professional legal services and any other lawful activities permitted of Professional Service Corporations under the laws of the State of Florida.

Article 4. Capital Stock.

This corporation is authorized to issue up to One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock. All shares shall be of a single class and shall only be held by other professional corporations, professional limited liability companies, or individuals who themselves are duly licensed or otherwise legally authorized to render legal services.

Article 5. Initial Registered Agent and Street Address.

This corporation shall initially have, and shall always keep at least, one (1) Director. The foregoing right of indemnification shall be inclusive of any other rights to which any director, stockholder or officer may be entitled as a matter of law.

Article 10. Amendments.

The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the Shareholders or Directors is subject to this reservation.

Article 11. Corporate Duration.

The duration of the corporation shall be perpetual.
