**ARTICLES OF INCORPORATION
OF
FRANK D. STEWARD, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I

The name of this Corporation shall be FRANK D. STEWARD, INC.

Article II

The principal place of business and mailing address of this Corporation shall

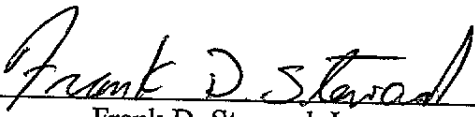

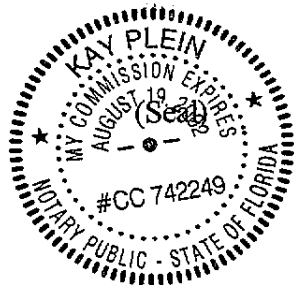
