**ARTICLES OF INCORPORATION
OF
KATFISH TRADERS, INC.**

ARTICLE I - KATFISH TRADERS, INC.

The name of the corporation is KATFISH TRADERS, INC..

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of filing the Articles with the Department of State.

ARTICLE III - PURPOSE
