2000 shares = Gareth H. Bullock

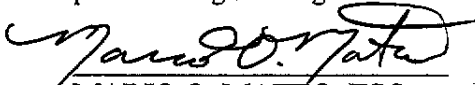
Article V: Preemptive Rights: The partner shareholders may reserve preemptive rights upon a vote of the board of directors (senior partners).

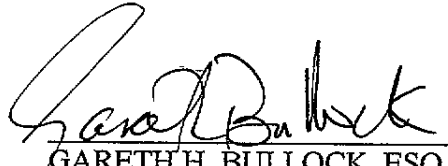
