## CERTIFICATE OF INCORPORATION OF E!MAGE PRODUCTIONS AND ADVERTISING, INC.

#### ARTICLE I

The Name of this corporation is: E!MAGE PRODUCTIONS AND ADVERTISING, INC.

## ARTICLE II GENERAL NATURE OF BUSINESS

The general nature of this business shall be that of MEDIA PRODUCTION AND ADVERTISING and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz.:

- (A) To improve, buy, sell, exchange, mortgage, rent, lease, invest in, build, erect, equip, maintain, deal in and with, dispose of, manage and operate real property of whatsoever nature or kind, as owner, agent, factor, or broker; to build, construct and alter houses, buildings and structures of whatsoever nature or kind, and to develop real property generally, to loan money upon real and personal property and to take mortgages and bonds, and assignments of mortgages and bonds upon real and personal property of whatsoever nature or kind; and to borrow money thereon by mortgages or otherwise; to buy, sell and deal in bonds and loans secured by mortgages or other liens on real property or personal property of all kinds and description.
- (B) To purchase, manufacture, acquire, hold, own, mortgage, hypothecate pledge, cease, sell, assign, transfer, investing in, trade in, deal in, borrow and lend money upon goods, wares, merchandise an real and personal property of every kind and description.
- (C) To act as agent, broker or attorney in fact for any persons, firms or

corporations in buying, selling in real or personal property of whatsoever nature or kind and any and every estate and interest therein, and chooses in action and secured thereby, judgements resulting therefrom, and other person property collateral thereto, in making or obtaining loans upon such property, in supervising, managing and protecting such property and loans and all interests in and claims affecting the same, in effecting insurance against fire and all other risks thereon, and in managing and conducting any legal actions, proceedings and business relating to any of the purposes herein mentioned or referred to; to register mortgages and deeds of trust of real property or chattells real and all other securities collateral thereto; to investigate and report upon the credit and financial solvency and sufficiency of borrowers and sereties upon such securities; and to transact all or any other business which may be necessary or incidental or proper to the exercise of any or all of the purposes of the corporation.

- (D) To subscribe for, purchase, invest in, hold, own, assign, pledge, and otherwise dispose of shares of capital stock, bonds, mortgages, debentures notes and other securities, obligations, contracts and evidences of indebtness of any persons, firms, associations, or other corporations, whether domestic or foreign, and to exercise in respect for any such shares of stocks, bonds and other securities, any and all rights, powers and privileges of individual ownership, including the right to vote thereon, to issue bonds and other obligations, and to secure the same by pledging or mortgaging the whole or any part of the property of the company, and to sell such bonds and other obligations for proper corporate purpose, and to do any and all acts and things tending to increase the value of the property at any time held by the company.
- (E) To acquire, hold, undertake and fully exploit the good will, property, rights, franchises, and assets of every kind, and the liabilities of any person, firm, association or corporation, either wholly or partly, and to trade for the same in cash, stocks, or bonds of the company or otherwise.
- (F) To borrow money and contract debts when necessary in the purchase or acquisition of real personal and intangible property, business rights or franchises, or for additional working capital, or for any other object in or about its business or affairs and without limit as to amount, to incure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidences of indebtness of all kinds,

weather secure by mortgage, pledge, deed of trust or otherwise.

- (G) In any manner to acquire, enjoy, utilize, and to dispose of patents, copyrights, and trademarks, and any license or other rights of interest therein and thereunder.
- (H) To conduct business and operations and to have one or more offices and hold, purchase, mortgage, lease, dispose of, deal in, and convey real and personal property without restrictions in this state and in any other of the several states, territories, possessions, and dependencies of the United States, the District of Columbia, and any and all foreign countries.
- (I) To purchase or otherwise acquire, become interested in, deal in and with, invest in, hold, pledge, sell, mortgage, lend money on, exchange or otherwise dispose of, or turn to account or realize upon as owner, agent, broker, or factor, all forms of securities, including stocks, bonds, debentures, mortgages, notes, evidences of indebtness, leases, options, certificates of interest, participation certificates, voting trust certificates evidencing shares of or interest in common law trust, trusts and trust estates or associations, certificates of trust or beneficial interest in trusts, mortgages, contracts and other instruments, securities and rights; to investigate and report with respect to, and to undertake, carry on, aid,, assist or participate in the organization, liquidation or reorganization of financial, commercial, mercantile, manufacturing, industrial or other business concerns, firms, associations, and corporation; to institute, participate in or promote commercial, mercantile, financial and industrial enterprises and operations.
- (J) To engage in and carry on any advertising business in connection with property of any nature, owned, leases, and otherwise acquired by this corporation, as principal or agent, with power to let contracts every kind and nature that may be conductive to the accomplishment of any purpose of the corporation.
- (K) To do any and all things, and everything necessary and proper for the accomplishment of the objects enumerated in this Certificate of Incorporation or any amendment thereto necessary and incidental to the protection and benefit of the corporation, and in general to act in any lawful business necessary or incidental to the attainment of the objects of the corporation, weather or not such business is similar in nature to the objects set forth herein, it being understood that the enumeration of specific powers in this Certificate of Incorporation shall not be deemed or be exclusive, but all other lawful powers conferred by the statutes of the

State of Florida are hereby included.

### ARTICLE III CAPITAL STOCK

The capital stock of this corporation E!MAGE PRODUCTIONS AND ADVERTISING, INC. shall be 1000 shares of \$1.00 per value. All of said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this corporation.

#### ARTICLE IV PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation E!MAGE PRODUCTIONS AND ADVERTISING, INC. of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE V DURATION

This corporation E!MAGE PRODUCTIONS AND ADVERTISING, INC. shall exist perpetually unless sooner dissolved according to law.




