# ARTICLES OF INCORPORATION

## ARTICLE I

### NAME

The name of the Corporation is: CENTRAL FLORIDA WIRELESS, INC., a domestic corporation which is not a member of any affiliated group.

## ARTICLE II

### PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 603 US Hwy 41, North, Ruskin, Florida 33570.

## ARTICLE III

### PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of cellular phone and pager sales; and
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business; and






