# Articles of Incorporation of MARGATE PLUMBING REPAIR, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I

The name and initial address of this corporation shall be MARGATE PLUMBING REPAIR, INC., 5130 NW 15th Street, Suite A, Margate, FL 33063.

#### ARTICLE II
