ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- CULI-SERVICES OF CENTRAL FLORIDA INC

This corporation shall exist perpetually.



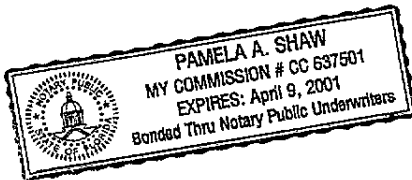
