HOLLOW LEG, INC.

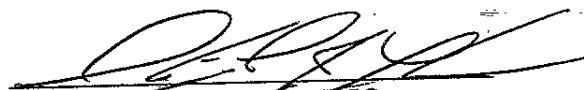
