ARTICLES OF INCORPORATION

TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: ROBINSON'S LANDSCAPING & LAWN SERVICE, INC., 408


