CUMULATIVE VOTING FOR DIRECTORS



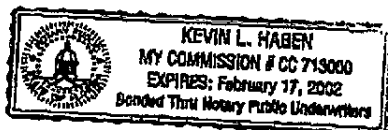
