## ARTICLES OF INCORPORATION OF SUNSHINE RECORDS, INC.

The undersigned, for the purposes of forming a corporation under the Florida Ceneral Corporation Act, hereby adopts the following Articles of Incorporation.

#### **ARTICLE I - NAME**
