ARTICLE I - NAME

The name of this corporation is Rybo 60 Corp.

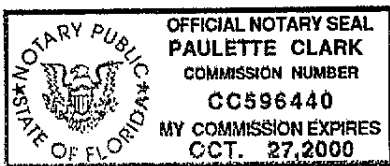
