THE UNDERSIGNED, who desire(s) to form a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be Growing Child Pediatrics, P.A.

ARTICLE II - PURPOSES

This corporation is organized for the purpose of transacting any or all lawful business as a medical doctor.

ARTICLE III - DURATION

The term of existence of the Corporation is perpetual.

The number of shares of capital stock that the Corporation is authorized to issue is 1,000 shares with a par value of \$1.00 all of which shall be voting common shares.


These Articles of Incorporation may be amended in the manner provided by Florida law.




