ARTICLES OF INCORPORATION
OF

LA DAMA ENTERPRISES, INCORPORATED

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") shall be **LA DAMA ENTERPRISES, INCORPORATED**.

ARTICLE II

The principal place of business and mailing address of the Corporation is **407 Lincoln Road, Suite 701, Miami Beach, FL 33139**.

ARTICLE III

The existence of the Corporation shall begin on **MAY 31, 1999**

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$1.00 per share, all of which shall be Common Shares. 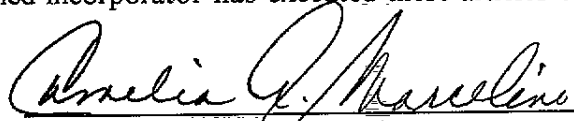

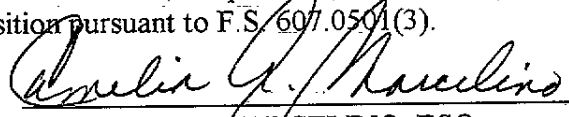
