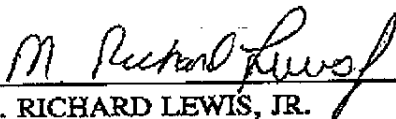
ARTICLE VII-BYLAWS

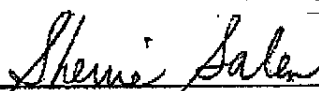
