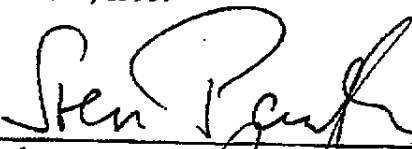
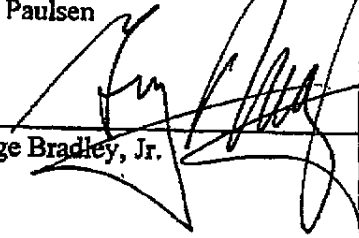
ARTICLE X - INDEMNIFICATION

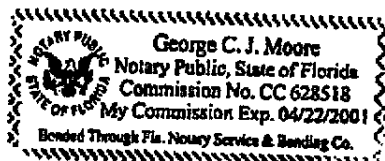
