ARTICLES OF INCORPORATION
OF

PURSUANT TO Chapter 607 of the Florida Statutes (1998), the undersigned, acting as sole incorporator of NEUROLOGY ONLINE, INC., hereby adopts and files the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is NEUROLOGY ONLINE, INC.

ARTICLE II

Duration

The period of existence of this corporation is perpetual.

ARTICLE III

Purpose

The corporation is a professional service corporation and is organized for the purpose of engaging in any lawful act or activity for which corporations may be organized under Chapter 607, Florida Statutes.
