





OF
NETCOR INFORMATION SERVICES INC.**


- FIRST: The name of this corporation is **NETCOR INFORMATION SERVICES INC.**
- SECOND: **Netcor Information Services Inc.** is organized for the purpose of **transacting any lawful business** for which corporations may be formed in Florida.


