Corporation Act.

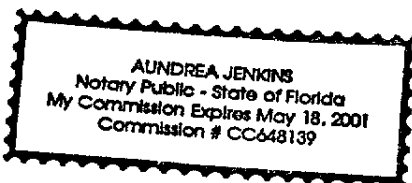
