ARTICLE I
CORPORATE NAME

The name of this corporation is G&M CLEANERS INC., and its principal place of business shall be located at 5002 Broadway, West Palm Beach, FL, 33407.

ARTICLE II
CORPORATE NATURE

This is a corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
