The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be:

ARTICLE II. NATURE OF BUSINESS

ARTICLE III. TERM OF CORPORATION

This corporation shall have perpetual existence.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock.

a meeting and filed with the Secretary of the corporation as part of the corporate records.

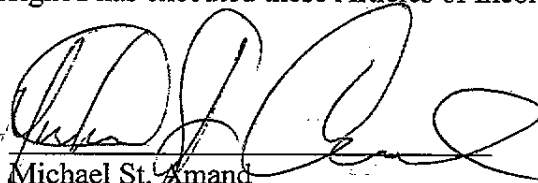
ARTICLE X. AMENDMENT

The effective date of these Articles of Incorporation shall be the date of filing.

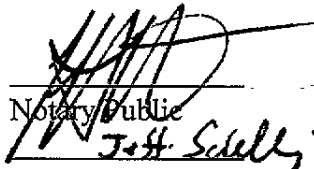

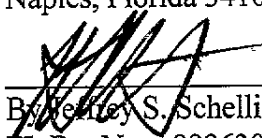
