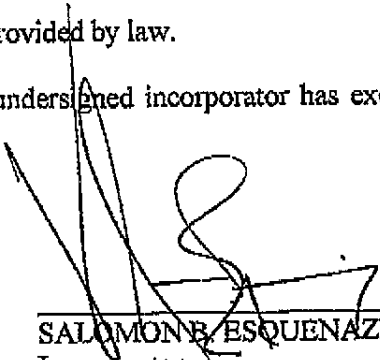
ARTICLE VIII. BYLAWS

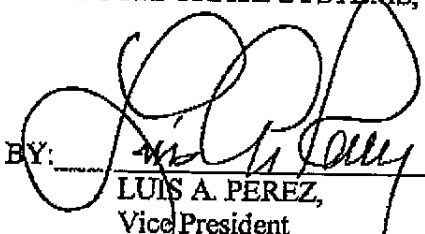
