

ARTICLE I. NAME

The name of the corporation shall be

FJB Entertainment, Inc.

The principal place of business of this corporation shall be 2728 NW 47th Lane;

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful business or activities as permitted under the laws of the United states, the State of Florida or any other State.

ARTICLE III. CAPITAL STOCK
