ARTICLES OF INCORPORATION

OF

ALFONSO DOMINGUEZ, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is ALFONSO DOMINGUEZ, INC. The physical address of the Corporation is 11997 South U.S. Highway 441, Belleview, Florida 34420. The mailing address of the Corporation is Post Office Box 2227, Belleview, Florida 34421-2227.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is five hundred (500) shares of common stock having a par value of One and NO/100 Dollar (\$1.00) per share.

The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one. #### ARTICLE IX - INDEMNIFICATION

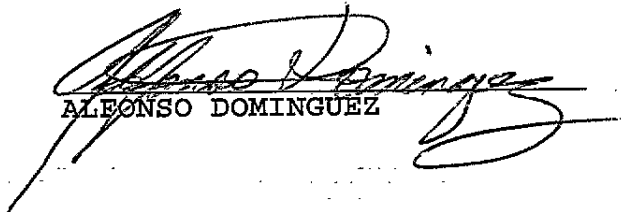
The Corporation shall indemnify its officer(s), director(s) and authorized agent for all liabilities incurred directly,

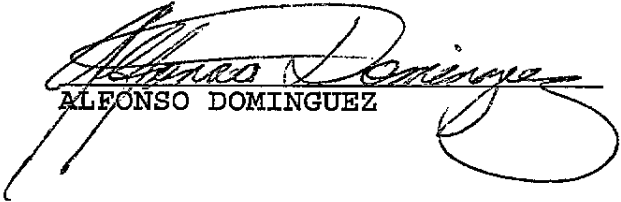
