ARTICLE IV: SHARES

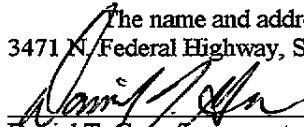

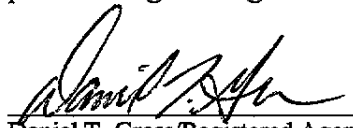
