**ARTICLES OF INCORPORATION  
OF**

**Leinbach Dental Repair, Inc.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

Leinbach Dental Repair, Inc.

The principal place of business of this Corporation shall be 9620 123<sup>rd</sup> Lane North, Seminole, Florida 33772.

ARTICLE II. NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 shares of voting common stock having \$1 par value per share and 1000 shares and 1000 shares of non-voting common stock having \$1 par value per share.

#### ARTICLE IV. ADDRESS AND REGISTERED AGENT

The street address of the initial registered office of the Corporation shall be 9620 123<sup>rd</sup> Lane North, Seminole, Florida 33772, and the name of the initial registered agent of the Corporation at that address is Philip Leinbach who accepts the designation by his signature below. He is familiar with and accept the responsibilities as Registered Agent.

#### ARTICLE V. TERM OF EXISTENCE

This Corporation is to exist perpetually.

#### ARTICLE VI. PREEMPTIVE RIGHTS

Every shareholder upon the sale for cash of any new stock of this Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.

This Corporation shall have no Directors, initially. The affairs of the Corporation will be managed by the shareholders until such time Directors are designated by the Bylaws.

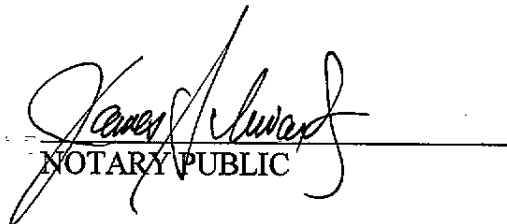

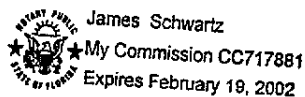
