**ARTICLE I
CORPORATE NAME**

The name of the Corporation is OUTRIDER FOUR INVESTMENTS, INC.

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**

The street address of the principal office of the Corporation is located at 201 South Orange Avenue, Suite 105, Orlando, Florida 32801 and the mailing address of the Corporation shall be 101 East Central Boulevard, Orlando, Florida 32801

**ARTICLE III
REGISTERED OFFICE/AGENT**

**ARTICLE IV




