ARTICLE OF INCORPORATION

ARTICLE ONE

The name of the corporation is A NEW BEGINNING, CORP. The principal address of the corporation is: 11985 Bird Drive, Miami, FL 33175.

The period of its duration is perpetual.

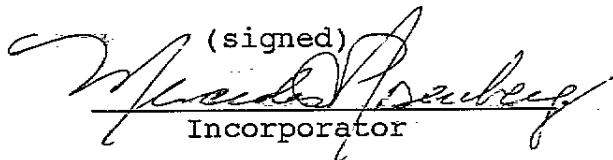
ARTICLE EIGHT
