**ARTICLES OF INCORPORATION
OF
J.MMM.Web Enterprises, Inc.**

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, Florida Statutes, Chapter 607, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE - Name

The name of this corporation is **J.MMM.Web Enterprises, Inc.**

ARTICLE TWO – Duration

The period of its duration is perpetual.

ARTICLE THREE – Purpose

- (A) To engage in the business of merchandising, and generally to acquire any products or rights therein, maintain equipment, intellectual property, intangibles and other things in connection therewith.
- (B) To carry on its operations and conduct business in any state, in the District of Columbia, and in any territory, dependency, or possession of the United States, and in any foreign country;
- (C) Additionally, this corporation is organized under the corporation laws of this state may now or hereafter lawfully do, to do, either as principal or agent and either alone or in connection with other corporations, firms, or individuals, all and everything necessary, suitable, convenient, or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this corporation or to enhance the value of its business plan; and in general to do any and all things and exercise any and all powers, rights, and privileges which a corporation may now or hereafter be organized

to do or to exercise under the corporation laws of this state or under any act amending those laws, supplemental thereto, or substituted therefore.

ARTICLE FOUR - Capital Stock

The corporation is authorized to issue 100 shares, all of one class, at \$5.00 par value.

ARTICLE FIVE - Initial Registered Office and Agent

Members of the Board of Directors may participate in special, regular and annual meetings of the board of directors by means of conference telephone or similar communications equipment as provided by law.


ARTICLE TEN - Informal Action of Directors



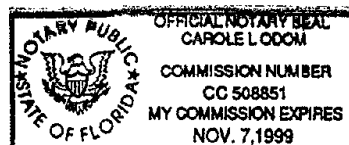
