ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is A & H BEEPER & CELLULAR ACCESSORIES #8, INC.

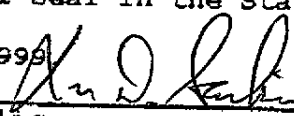
