# ARTICLES OF INCORPORATION OF eExecutiveSearch, Inc.

TALLAHASSEE, FLORIDA

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

## ARTICLE I

The name of the corporation ("Corporation") is eExecutiveSearch, Inc.

# ARTICLE II

The existence of the corporation shall begin on June 15, 1999.
