

ARTICLES OF INCORPORATION

OF

GROOVEHOUSE MUSIC CORPORATION



THE UNDERSIGNED incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation is GrooveHouse Music Corporation (the "Corporation").

SECOND: The principal office address and mailing address of the Corporation is 601 Brickell Key Drive, Suite 802, Miami, Florida 33131.

THIRD: The total number of shares of stock which the Corporation shall have authority to issue is one thousand (1000) shares of common stock, par value \$.01 per share. Each share of Common Stock shall be entitled to one vote.

SIXTH: The Corporation is organized for the purpose of transacting any and all lawful activities or business for which corporations may be formed under Chapter 607 of the Florida Statutes.

SEVENTH: All corporate powers shall be exercised by or under the authority of, and the business and affairs of the Corporation managed under the direction of, its Board of Directors. This Corporation shall have two (2) directors initially. The names and addresses of the initial members of the Board of Directors are:
