ARTICLES OF INCORPORATION

OF

JOE STOUT, INC.

The undersigned subscriber to these Articles of Incorporation, a person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is: **JOE STOUT, INC.**

ARTICLE II

This corporation shall exist perpetually.

This Corporation shall have no Directors. The business of the Corporation shall be managed by the stockholders.




