ARTICLE I

The name of this corporation is Di Nicola's Inc. Whose principal address is 5981 Funston Street , Suite A1 Hollywood, Florida 33023

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage as a computer repair, a business permitted under the laws of the State of Florida.
