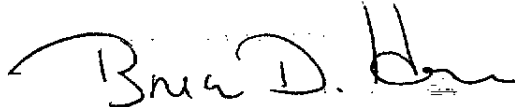

**Articles of Incorporation
of
Sun Belt Development and Construction, Inc.**

Article I. Corporate Name and Initial Corporate Address

The name of this corporation is **Sun Belt Development and Construction, Inc.**, and the initial corporate street address and mailing address is 201 Timber Lane, Panama City, Florida 32405.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Stock

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, having a par value of \$5.00 per share.

Article IV. Term of Existence

This corporation shall have perpetual existence commencing upon filing of the articles.

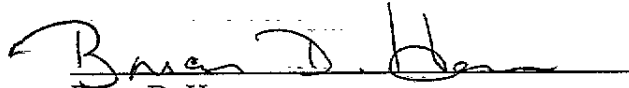

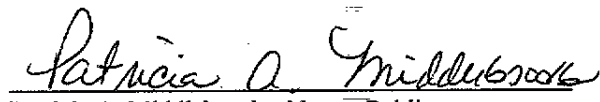
