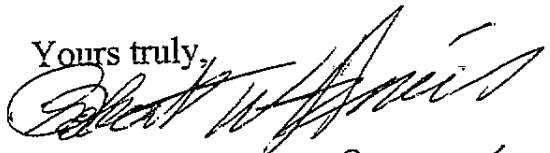
Dear Miss Shepard,

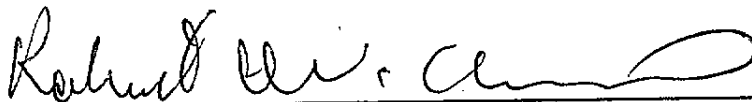
